ORDER

Sub: Debarment of "Best Flavours, AS/8/181/1/8/05, BL-B, Tulip Garden, Shop No – 1, 211, Bus Stand, Dashodrone, P.O. – Gopalpur, P. S – Baguihati, Pin - 700136" from participating in the bidding/procurement of all future projects under Public Works Department, Government of West Bengal.

WHEREAS, the 2nd meeting of Debarment Committee, Public Works Department was held on 27.01.2026 at 4:00 p.m. at the chamber of the Engineer-in-Chief-I, &Ex-officio Secretary, Public Works Department, 8th Floor, Nabanna, 325, Sarat Chatterjee Road, Howrah- 711102 on the matter: Allegation against the bidder – “Best Flavours, AS/8/181/1/8/05, BL-B, Tulip Garden, Shop No – 1, 211, Bus Stand, Dashodrone, P.O. – Gopalpur, P. S – Baguihati, Pin - 700136”, in connection with the violation of terms and conditions of Tender no. e-NIB No.- 02 of 2025 -26 of the Superintending Engineer, Central Highway Circle, Public Works (Roads) Directorate for the work of “Collection of Toll on Shree Gouranga Setu over river Bhagirathi at Nabadwip in the district of Nadia under Nadia Highway Division – I, Public Works (Roads) Directorate”.

AND WHEREAS, the members of the Suspension Committee of South Zone, Public Works (Roads) Directorate headed by the Chairperson-Convenor of the Suspension Committee and Chief Engineer-II, South Zone, Public (Roads) Works Directorate in the meeting held on 11.12.2025 had found the agency " Best Flavours, AS/8/181/1/8/05, BL-B, Tulip Garden, Shop No – 1, 211, Bus Stand, Dashodrone, P.O. – Gopalpur, P. S – Baguihati, Pin - 700136" guilty as per terms of contact Clause 5.1 of the e-NIB by willfully submitted false and falsified documents and committed 1st degree offence as per clause 5.1 of Memorandum No.547-W(C)/1M-387/15 dated 16.11.2015 of Public Works Department which is a part of the tender agreement e-NIB No.- 02 of 2025 -26 of the Superintending Engineer, Central Highway Circle, Public Works (Roads) Directorate. The Suspension Committee suspended the agency as per clause 5.1 of Memorandum No.547-W(C)/1M-387/15 dated 16.11.2015 of Public Works Department and accordingly the agency was suspended from participating in the bidding/procurement of all future projects under Public Works

Department, Government of West Bengal for a period of 6 (Six) months w.e.f the date of order vide Memo No – 1052-CE(R)/SOUTH/C-10(Part-IV) Dated:11.12.2025 of Chairperson & Convenor of the Suspension Committee and Chief Engineer-II, South Zone, Public Works (Roads) Directorate;

AND WHEREAS the Chairperson & Convenor of the Suspension Committee and Chief Engineer-II, South Zone, Public (Roads) Works Directorate had forwarded to the Debarment Committee for taking necessary action, vide his letter no. 1053-CE(R)/SOUTH/C-10(Part-IV) Dated: 11.12.2025 addressed to the Engineer-in-Chief-I, &Ex-officio Secretary, Public Works Department and Chairperson & Convenor of the Debarment Committee;

AND WHEREAS the Chairperson & Convenor of the Suspension Committee and Chief Engineer-II, South Zone, Public (Roads) Works Directorate recommended to the Debarment Committee for taking necessary action against the agency in terms of para under Sl No- 7.1 (C) of the Memorandum No.547-W(C)/1M-387/15 dated 16.11.2015 of Public Works Department, vide his letter no. 1053-CE(R)/SOUTH/C-10(Part-IV) Dated: 11.12.2025 addressed to the Engineer-in-Chief-I, &Ex-officio Secretary, Public Works Department and Chairperson & Convenor of the Debarment Committee;

AND WHEREAS the concerned agency, “Best Flavours”, had been served the notice by the Engineer-in-Chief-I & Ex Officio Secretary, Public Works Department & Chairperson-Convener, Debarment Committee, Vide Memo No. 1148-ENC-I/25 dated 22.12.2025, to attend the Hearing scheduled on 08.01.2026 at 1.00 p.m. at the chamber of the Engineer-in-Chief-I, &Ex-officio Secretary, Public Works Department, 8th Floor, Nabanna, 325, Sarat Chatterjee Road, Howrah- 711102, but the said agency failed to attend the said hearing;

AND WHEREAS the concerned agency, “Best Flavours”, had again been served 2nd notice by the Engineer-in-Chief-I & Ex Officio Secretary, Public Works Department & Chairperson-Convener, Debarment Committee, Vide Memo No. 45-ENC-I/26 dated 15.01.2026, to attend the Hearing scheduled on 27.01.2026 at 4.00 p.m. at the chamber of the Engineer-in-Chief-I, &Ex-officio Secretary, Public Works Department, 8th Floor, Nabanna, 325, Sarat Chatterjee Road, Howrah- 711102, but the said agency again failed to attend the said hearing;

AND WHEREAS considering all facts and scrutinizing of all the relevant and available documents with the Debarment Committee, it is observed that the alleged agency willfully submitted false and falsified documents in support of their credential and thus violating the contractual agreements in terms of clause 5.1 of the memorandum no. 547-W(C)/1M-387/15 dated 16.11.2015;

AND WHEREAS The Debarment Committee recommended to debar the concerned agency, “Best Flavours, AS/8/181/1/8/05, BL-B, Tulip Garden, Shop No – 1, 211, Bus Stand, Dashodrone, P.O. –
