**OFFICE ORDER**


In terms of PWD Notification No.40, dated-25.02.2014, five post of Executive Engineer (Mechanical) have been converted to the Executive Engineer (Electrical), PWD to provide promotional benefit to existing Assistant Engineer of Mechanical Wing i.e as on 28.02.2014, for giving natural justice, such five nos post of Executive Engineer (Electrical) are being filled up from feeder post of Assistant Engineer(Mechanical) on promotion as deemed deputation to function as TA to superintending Engineer, PWD vide PWD Establishment Order No-849-E/E-I/2M-44/2013, dated-28.02.2014.

After careful examination, it has been observed that all such incumbents of Assistant Engineer (Mechanical) who have joined in the post of Assistant Engineer (Mechanical) on or before promulgation of aforesaid order have already been promoted up till now. And there is no such incumbent left for consideration for promotion to the post of Executive Engineer (Electrical) from the feeder post of Assistant Engineer (Mechanical).

As such Sri Tapas Das, Executive Engineer (Mechanical) now posted at TA to Superintending Engineer, Southern Electrical Circle, PWD will retire on superannuation on attaining the age of 60 (Sixty) years on 30.06.2022 and thereby the said post will get vacant.
