ORDER

A maximum number of 542 Computer Operators were deployed by WEBEL Technology Limited for rendering their service in different offices under Public Works Department over a span of nearly two months from 16.02.2014 onwards in pursuance of this Department's Notification No.152 dated 30.08.2013 read with order No.193-E dated 21.01.2014.

2. They were deployed with payment of remuneration @ Rs. 10,557/- (i.e. inclusive of minimum wages, bonus, P.F., E.S.I. and administrative/ agency charge) plus Service Tax as applicable from time to time per head per month in terms of this Department's Order No.3235-E dated 31.10.2014. Subsequently, it was enhanced to Rs.11101/- (i.e. inclusive of minimum wages, bonus, P.F., ESI and administrative / Agency charges) in terms of this Department's Order No.577-E dated 02.03.2016. The matter of enhancement of their monthly remuneration was under active consideration of the State Government for quite some time past.
3. Now, in partial modification of this Department's Orders No.3235-E dated 31.10.2014 and 577-E dated 02.03.2016 and in pursuance of the Office of the Labour Commissioner's Order No.1421/Stat/2RW/32/94/LCS/JLC dated 29.12.2016, the undersigned is directed by order of the Governor to say that the Governor has been pleased to allow payment of minimum wages @Rs.9132/- per head per month and statutory payment of bonus of Rs.761/-, P.F. of Rs.1220/- and E.S.I. of Rs.470/- (i.e. Gross remuneration of Rs.11,583/- per head per month) with payment of administrative / agency charge @Rs.5% on minimum wages, i.e. Rs.457/- per head per month plus Service Tax @10% on Gross remuneration and administrative charge i.e. Rs.1204/- amounting to a total of Rs.13244/- per head per month w.e.f. 01.01.2017 and until further orders.
4. This issues with the concurrence of the Finance Department vide their U.O. No. Group-P2/2017-2018/0079 dated 25.04.2017.
