Sub: *Earmarking a dedicated head for appropriation of monthly wages of sanctioned posts of Part Time Karmabandhu(s) serving in various offices under Public Works (Roads) Directorate – Regarding.*

A few offices under the aegis of Public Works (Roads) Directorate had possessed the concurrence of the Finance Department for engagement of Part time Karmabandhu(s) on temporary basis to a few number of posts under them.

The Government in the Public Works Department has been undertaking the process of extension/retention of such posts of Part time Karmabandhu(s) by issuing various orders of this Department from time to time. The pay of these part time staff had been marked under the detailed head "13-04-Other Office Expenses" in these orders.
