ORDER

03 (Three) Junior Engineers in Electrical wing of PWD [i.e. 02 (Two) Junior Engineers (IT) and 01 (one) Estimator in the rank of Junior Engineer (IT), erstwhile Sub Assistant Engineers] were deployed by WEBEL Technology Limited initially for a period of 01 (one) year considering urgent requirement of JEs in PWD vide this Department's order No. 292-E/E-I/5A-03/14 Dated 03.02.2015 & order No. 631-E/E-I/5A-03/14 Dated 16.03.2015 with necessary concurrence of Finance Department vide their UO No. 2140-Group P2 Dated 19-08-14.

2. Their contractual service was extended several times with required F.D's concurrence. Last renewal in respect of their contractual service was given vide this Department's order No. 3345/PWD-11054/1/2018-WORKS WING dated 05.09.2024 for a period of 1 (one) year w.e.f the date of expiry of their earlier tenure.

3. Now the Governor has been pleased to extend the tenure of their deployment for another 01 (one) year w.e.f the date of expiry of their earlier tenure subject to the condition that none of them exceeds the age of 60 years at the time of joining on existing terms and conditions.
