**ORDER**

Consequent upon restructuring of the engineering set up of Public Works Department vide Notification No.-15 dated 06.02.2017, the Governor has been pleased to declare Executive Engineer, National Highway Division-II, P.W.(Roads)Dte. to act as D.D.O. for the office of Executive Engineer, National Highway Division-II, P.W.(Roads)Dte. at Kharagpur in Paschim Medinipore District as the said office has been shifted to Kharagpur Treasury Jurisdiction from Midnapore.

2. In this regard T.R.-4.018 & T.R.-4.019 of W.B. T.R. 2005 should be observed.
3. The said D.D.O. is attached to Kharagpur Treasury.
4. The Governor has further been pleased to accord permission for drawal of the fund from security deposit and works deposit A/C maintained in old treasury in open cheque after proper re-conciliation of the balances and deposit the same in New Treasury along with TR 7 challan in the new works deposit A/C and security Deposit A/C to be opened in consultation with the A.G. W.B.
5. After new DDO Code is activated in new treasury, the DDO Code in old Treasury may be kept activated for the period till the fund of deposit A/Cs are transferred from old Treasury to new Treasury. Transfer to deposit A/C balance from old Treasury to new Treasury will be through e-Billing. After transfer of fund, old DDO Code and old Operator Code for works Deposit and security deposit A/C will be deactivated.
6. The order issues with the concurrence of the Finance Department, Group-'T' vide their U.O. No. Group-T/2017-2018/0100 dated 11.05.2017.
7. The Principal A.G.(A&E), W.B. and all other concerned are being informed.
