

Hon'ble State Chief Information Commissioner, West Bengal has expressed his dissatisfaction over such fruitless practice which tantamounts to wasteful expenditure from the government exchequer, I am therefore to request you to kindly convey the same to all public authorities under your administrative control to desist from such practice and oblige.
