A total number of 124 (one hundred and twenty four) numbers of Contractual Computer Operators under this Department was brought under the purview of Finance Department Memo No. 1107 F(P) dated 25.02.2016 and they were allowed all the financial, service, terminal and medical benefits w.e.f. 01.03.2016 as enumerated in Finance Department's aforementioned memo with due concurrence of the Finance Department vide their U.O. No. Group P2/2016-17/0277 dated 27.09.2016 in terms of this Department's Order No. 2568-E /E-I/2M-10/2009 dated 17.10.2016.

2. As out of the 124 Contractual Computer Operators, 04 no. of Computer Operators did not turn up for verification of their documents while the other 02 no. of Computer Operators failed to produce any document in support of their first engagement as Contractual Computer Operators under this Department, they were excluded from the purview of the benefit provided in terms of Finance Department's Memo No. 1107- F(P) dated 25.02.2016 and the benefit is extended to rest 118 nos. of Contractual Computer Operators in the first lot in the aforementioned G.O. of this Department.

3. Meanwhile, out of the 04 no. of Computer Operators who did not turn up for verification of their documents previously, 02 no. of Computer Operators have turned up for verification of their documents while the other 02 no. of Computer Operators who failed to produce any document in support of their first engagement as Contractual Computer Operators under this Department, have now furnished the same.

4. Now, in continuation of this Department's earlier Order No. 2568-E /E-I/2M-10/2009 dated 17.10.2016, the benefit in terms of Finance Department's Memo No. 1107-F(P) dated 25.02.2016 as already extended to 118 no. Contractual Computer Operators under this Department in the first lot, is hereby further extended to 04 no. of Contractual Computer Operators as detailed in Annexure- I in the second lot.

5. The payment of their monthly remuneration and other amounts relating to service and terminal benefits will be debitable to the detailed head of account "02 wages" subordinate to the respective major/ minor head of A/C.

6. This issues with the concurrence of the Finance Department vide their U.O. No. Group- P2/ 2016-2017/ 0277 dated 27.09.2016.
