**ORDER**


30(Thirty) contractual Assistant Engineers (Civil) and 20(Twenty) contractual Assistant Engineers (Electrical) were deployed by Webel Technology Limited for a period of 06(six) months considering urgent requirement of Assistant Engineers under Public Works Department vide this Department's memo No. 315-E Dated 05-02-2015 & No. 353-E Dated 10-02-2015 with necessary concurrence of the Finance Department vide their U. O. No. Group P2/2014-2015/2216 Dated 09-09-14 read with U. O. No. Group P2/2014-2015/2279 Dated 15-10-2014.

2. Their contractual service was extended several times with required F.D.'s concurrence. Last renewal in respect of their contractual service was given vide this Department's order No.1054/PWD-11054/1/2018-WORKS WING-Dept. of PWD Dated 19-08-2020 for a period of 1(one) year w.e.f. the date of expiry of their earlier tenure.

3. Now after careful consideration of the matter as a whole, the Governor has been pleased to extend the tenure of their deployment for another 01(one) year w.e.f. the date of expiry of their respective tenure keeping earlier terms and conditions unchanged.

5. This order issues with the concurrence of the Finance Department vide their U.O. No. Group P2/2021-2022/0184 Dated 31-08-2021.




