
**ORDER**

A maximum number of 26(Twenty six) Junior Engineers(Electrical) were deployed by WEBEL Technology Limited for a period of 12(Twelve) months for rendering their services in different offices under Public Works Department and consequently they were engaged in different offices under this Department vide PWD order No. 384-E/E-I/5A-03/14 Dated 12.02.2015. Subsequently they reported for duties over a span of nearly two weeks from the respective date issue of the order.

2. Thereafter their service was lastly extended for a further period of 3(three) months under this Department's memo No. 3126-E/E-I/5A/03/2014 Dated 28-08-2017 since their respective first dates of reporting for duties in different offices under PWD.




