
**Subject: Award of Higher Scale of pay in respect of Superintending Engineer (Civil), P.W.D.**

The service of the following 3(three) Superintending Engineers (Civil) under P.W.D have been found to be satisfactory and continuous on the date of completion of their services for more than 24 years in the rank of Assistant Engineer, Executive Engineer and Superintending Engineer including 1(one) year's service in the present rank of Superintending Engineer.
