MEMORANDUM

8 (Eight) workers rendering service as casual Group-D were engaged against vacant sanctioned posts under present Darjeeling Division, Public Works Directorate and are rendering their services for considerable periods at a stretch till date.

The terms and conditions of engagement and all other service benefits of casual workers in this state is governed by Finance Department's Memo No. 9008-F(P) dated 16.09.2011 read with Memo No.1107-F(P) dated 25.02.2016 and Memo No. 4011-F(P) dated 20.05.2013 ibid.

After careful consideration and observing all the necessary modalities, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to extend the service and all other benefits to 8 (Eight) workers rendering service as casual Group-D workers engaged under present Darjeeling Division as envisaged in Finance Department's Memo No. 9008-F(P) dated 16.09.2011 read with Memo No.1107-F(P) dated 25.02.2016 and Memo No. 4011-F(P) dated 20.05.2013 ibid.

The payment of their monthly remuneration and other amounts relating to their service and terminal benefits shall be debitible to the detailed Head of Accounts "02 wages" subordinate to the respective major / minor heads.


The terms and conditions of entitlement of remuneration and all other service benefits of these casual workers shall henceforth be governed by the aforesaid orders issued by Finance Department for casual workers.

The annual increment @ 3% shall be allowed to them on 1st July every year subject to satisfactory service rendered by the individual casual worker.

The date of effect of this order is from 01.03.2016.

The Principal A.G.(A&E), WB and all concerned are being informed accordingly.




