In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor is pleased hereby to make the following amendment in the rules regulating recruitment to the Engineering Services (Electrical Wing) under the Public Works Department, Government of West Bengal, published under this Department Notification No. 180, dated 12.08.1988 (hereinafter referred to as the said rules):-

***Amendment***

In the said rules,- in part-II-Method of Recruitment, in rule 4, for clause (a), substitute the following clause:-

- (a) Chief Engineer (Electrical): The post of Chief Engineer (Electrical) shall be filled up by selection from amongst the Additional Chief Engineer (Electrical)/Superintending Engineer (Electrical) including from the officers holding the post designated as Superintending Engineer (Selection Grade), and Assistant Chief Engineer:

Provided that a selection Committee shall be constituted for selection to the post by order.

This is issued with the concurrence of Finance Department vide their U.O No. Group-P2/2023-2024/0555 dated 31.08.2023 read with the approval of State Cabinet in its meeting held on 12.10.2023 vide Cabinet Sectt. U/O No. CAB(D)-764 dated 13.10.2023.


