Subject: Misclassification of interest on loan to Government Servants under Minor head '800' instead of Minor head '118' below HOA '0049-04'.

In terms of Correction Slip No.-975, dated-30.11.2021 to the list of Major and Minor Heads of Account, a new Minor Head '118-Interest on loan to Government servants was opened below '0049-Interest Receipts -04-Interest Receipts of State /Union Territory Government with Legislature. Accordingly, Government of West Bengal issued Memorandum No:15-FB, dated-06.04.2023 whereby the opening of six new sub heads under the HOA '0049-04-118', pertaining to demand no 18, was notified to be operational from the financial year 2023-24. The memorandum ibid also stated that heads of account existing under '0049-04-800' will cease to be operative from the financial year 2023-24.

Scrutiny of VLC challan data for the financial year 2023-24(up to July'2023) revealed that the State Government is continuing booking under the old heads of account instead of the new heads opened under the new minor head '118' below '0049-04'. Hence it is obvious that the earlier heads of account have not been made inoperative in IFMS from the financial year 2023-24. As a result there is a misclassification of Rs.22.02 lakh (challan wise details enclosed) towards interest on loan to government servant.

In view of the above it is recommended that immediate steps may please be taken to make the older heads inoperative in IFMS and ensure correct representation of interest received on loans to government servants as per LMMH.
