NOTIFICATION

A proposal for establishing a setup within Public Works (Roads) Directorate under the administrative control of Public Works Department for assuming the project works undertaken by the West Bengal Highway Development Corporation Limited (WBHDCL), utilizing the existing manpower of WBHDCL was under active consideration of the Government for some time past.

This newly created establishment of Highway Projects within Public Works (Roads) Directorate will take with immediate effect and to make this Highway Projects wing under Public Works (Roads) Directorate fully operational, concerned office would be opened at HRBC Bhawan, 4th & 5th Floor, Kolkata -700021 until further order.
- 7. Retention of contractual employees directly engaged by WBHDCL and shifting of manpower engaged by WBHDCL through agency in new set up of Public Works (Roads) Directorate will be notified separately.
