They were deployed with payment for remuneration @ Rs.10,557/- (i.e inclusive of minimum wages, bonus, PF, ESI and administrative / agency charge) plus service tax as applicable from time to time per head per month in terms of this Deptt's Order no. 3235-E dated 31.10.2014. Subsequently, payment for monthly remuneration was enhanced from time to time and lastly, it was enhanced to Rs.12,040/- (i.e. inclusive of minimum wages, bonus, PF,ESI and administrative / agency charge) plus service tax as applicable from time to time in terms of this Deptt's Order no. 1571-E dated 05.05.2017. The matter of further enhancement of their monthly remuneration was under active consideration of the State Government for quite sometime past.

Now, in partial modification of this Department's Order no.1571-E dated 05.05.2017 lastly issued to this effect and in pursuance of the Labour Commissioner's circular no. 04/Stat/2RW/32/LCS/JLC dated 03.01.2018, the undersigned is directed by order of the Governor to say that the Governor has been pleased to allow payment of minimum wages @ 9270/- per head per month and statutory payment of bonus of Rs.772/-, P.F. of Rs.1,238/- and ESI of Rs.477/- amounting to a gross remuneration of Rs.11,757/- per head per month and payment of administrative / agency costs @ 5% on the cost of minimum wages of Rs.9,270/- amounting to Rs.464/- per head per month, total amounting to Rs.12,221/- per head per month plus GST as applicable on gross remuneration and agency charge during the period (i.e. from 01.01.2018 onwards) w.e.f. 01.01.2018 and until further orders.
