ORDER


A maximum number of 30 (thirty) Assistant Engineer (Civil) & 20 Assistant Engineer (Electrical) were deployed by WEBEL Technology Limited for a period of 6 (six) month for rendering their service in different offices under Public Works Department and consequently they were engaged in different offices under PWD vide PWD's Order No.315-E dated 05.02.2015 & No.353-E dated 10.02.2015. Subsequently, they reported for duties over a span nearly two week from 05.02.2015 on words.

2. Thereafter, their service was extended for a further period of 6 (six) months on three occasions for each term vide this Department's Order No.2003-E dated 13.08.2015, No.382-E dated 16.02.2016 and No.1991-E dated 08.08.2016 respectively since their respective first dates of reporting for duties in different offices under PWD.

Now, after careful consideration of the matter as a whole, the undersigned is directed by order of the Governor to say that the Governor has been pleased to extend the tenure of their deployment for a further period of 3 (three) months on hiring basis in different offices under Public Works Department on the same terms and conditions as laid down in this department's order No. 3630-E dated 08.02.2014 or till regular recruitment is made by the P.S.C., West Bengal, whichever is earlier.

5. The Principal Accountant General (A&E), W.B., Treasury Buildings, Kolkata-700-001 is being informed.


