ORDER


A total number of 3 (three) Junior Engineer (IT) were deployed by WEBEL Technology Limited for a period of 12 (Twelve) month for rendering their service in different offices under Public Works Department and consequently they were engaged in different offices under PWD in two phases vide PWD's Order No.292-E dated 03.02.2015 and No.631-E dated 16.03.2015. Subsequently, they reported for duties over a span nearly two week from the respective date issue of the orders.

2. Thereafter, their service was extended for a further period of 12(Twelve) months on one occasion vide this Department's Order No.383-E dated 16.02.2016 since their respective first dates of reporting for duties in different offices under PWD.

5. The Principal Accountant General (A&E), W.B., Treasury Buildings, Kolkata-700-001 is being informed.


