## **CIRCULAR**

Public Works Department in its earlier Circular No.232-W(C)/1M-253/19 dated 21.02.2019 laid down the following steps of adequate precautions, required to be taken up by the Engineer Officers concerned under their jurisdiction for ensuring regular inspection to prevent breeding of mosquito larva in any building / land / other asset maintained by Public Works Department:

- i) All open pits where water might accumulate and remain stagnant are to be closed down immediately.
- ii) Drainage is to be ensured so that water does not accumulate at any part.
- iii) Construction sites have to be specially monitored so that mosquito larvae do not breed in the site. Debris should be removed regularly. No water should be allowed to remain stagnant at the site.
- iv) Bleaching powder may be applied from time to time.
- v) Air Condition Machines should be cleaned regularly and water accumulation prevented.
- vi) Rubbish / garbage / debris should be removed.
- vii) Unwanted vegetation should be removed.

Moreover, in line with earlier Circular No.563-W(C)/1M-253/19 dated 05.08.2019 and No.564-W(C)/1M-253/19 dated 06.08.2019 of Public Works Department, it has been decided that Public Works Department will continue to undertake one time thorough cleaning of the following hospital premises being maintained by Public Works Department on top priority in consultation with the concerned authorities from the Health and Family Welfare Department:

- 1. Habra Hospital
- 2. Barasat Hospital
- 3. Barrackpore Hospital
- 4. Howrah State General Hospital
- 5. Bhatpara State General Hospital
- 6. Panihati State General Hospital
- 7. Diamond Harbour Medical College & Hospital
- 8. Uluberia Super Speciality Hospital
- 9. T.L.J. State General Hospital, Salkia, Howrah
- 10. R.G. Kar Medical College & Hospital
- 11. All hospital premises of Kolkata.

Other hospital premises should also be cleaned on priority basis by the Divisions concerned of PWD.
