#### **MEMORANDUM**

The terms and conditions of entitlement of remuneration and all other service benefits of these Daily-Rated Casual Workers shall henceforth be strictly governed by the aforesaid orders issued by Finance Department for casual workers read with PWD, Establishment Branch Memo No. 2057-E/E-II/2M-05/18 dated: 29.08.2018 respectively.

The annual increment @ 3% shall be allowed to them on 1st July every year subject to satisfactory service rendered by the individual casual worker.

This order is issued with the approval of Principal Secretary of this Department as well as with the concurrence tendered by Finance Department vide their UO No. Group P2/2018-2019/0406 dated 02.08.2018.
