MEMORANDUM

Whereas, a maximum number of 100 number retired employees were engaged for a period of one (01) year with a consolidated remuneration of ₹ 8000/- per month under various offices of Public Works (Roads) Directorate vide Memo No. 1M-55/12/37(20)-R/E dated 07.01.2014 of the P.W. (Roads) Directorate.

- 2. Whereas, the period of service of such engaged staffs was extended for a further period of six (06) months vide this Department's No. PR/N/E- 3E-04/2015/964 R/E dated 22.06.2015.
- 3. And whereas, no further engagement and extension was accorded to thereafter, which led to creation of huge vacancies in the post of Lower Division Clerks in various offices under P.W. (Roads) Directorate leading to difficulty in carrying out the official errands in a smooth 8 uninterrupted manner.
- 4. Therefore, the undersigned is directed to state that the Governor has been pleased to approve the engagement of One Hundred (100) number of retired L.D. Clerks for a period of one (01) year on contractual basis.
- 5. The appointing authority, in this immediate case, shall exercise extreme caution in engaging eligible candidates from retired personnel by abiding by the rules stated in extant orders of the Finance Department Government of West Bengal, nevertheless, the final authority to approve such engagement shall rest upon the Chief Engineer, Head Quarters, P.W. (Roads) Directorate. Such engagement shall not be made as a matter of course, but in extreme necessity.
- 6. The engagement to staffs through this order shall not be considered as reemployment and may not draw any analogy to that contained in this Department's Memo No. PR/N/E-1M-37/2016/708-R/E dated 10.04.2017. The incumbents shall be paid a remuneration which shall be governed in strict observance of Finance Department's No. 10935-F(P) dated 05.12.2011 i.e. last Pay minus Pension OR, ₹ 10,000/- whichever is minimum.
- The pay of such employees shall be drawn from the object head "02-Wages" under the functional major head "3054", subject to availability of fund.
- 8. This issues with the concurrence of the Finance Department (Group P2) vide their U.O No. Group P2/2017-2018/0093 dated 27.04.2017.
- All concerned are being informed accordingly.
