NOTIFICATION

A number of projects have been taken up by Social Sector wing under Public Works Directorate particularly in the newly created Alipurduar district and other districts in North Bengal but lack of working divisions results in improper and unbalanced work load of the existing set up in Social Sector wing in the districts of North Bengal.

As a result thereof, necessity for creation of Divisions in the Social Sector Wing under Public Works Department in Alipurduar and Uttar Dinajpur Districts by restructuring of the existing set up have been felt to cope with the requirement of proper implementation and execution of various projects relating to infrastructural works under the State Government.

- 2. Now in view of above the Governor is pleased, in the interest of public service as well as for better supervision of works, to reorganize some offices under North Bengal Construction Circle-I, Northern Circle, Social Sector, Nabanna Circle and Southern Circle, Social sector, all within P.W.Dte. in the following manner:
- (A) **North Bengal Construction Circle-I, P.W.Dte.**, with head quarter at Coochbehar town shall have five P.W. Divisions under its administrative jurisdiction, namely
 - a. Alipurduar Division, P.W.Dte., head quarter at Alipurduar town as existing division.
 - b. Coochbehar Division, P.W.Dte., head quarter at Coochbehar town as existing division.
 - c. Teesta Bridge Construction Division, P.W.Dte., head quarter at Mekhliganj town as existing division.
 - d. Alipurduar Division, Social Sector, P.W.Dte., head quarter at Alipurduar town. The Division is created by renaming, shifting and transferring Howrah Division, Social Sector, P.W.Dte. from the administrative jurisdiction of Southern Circle, Social Sector, P.W.Dte.
 - e. Coochbehar Division, Social Sector, P.W.Dte., head quarter at Coochbehar town. The Division is transferred from the administrative jurisdiction of Northern Circle, Social Sector, P.W.Dte.
 - (a) **Alipurduar Division, P.W.Dte.** under North Bengal Construction Circle-I, P.W.Dte., with head quarter at Alipurduar town shall have four existing Subdivisions under its administrative jurisdiction, namely
 - i) Alipurduar Sub-division, P.W. Dte., head quarter at Alipurduar town.

- ii) Alipurduar Construction Subdivision, P.W. Dte., head quarter at Alipurduar town.
- iii) Kamakhyaguri Subdivision, P.W. Dte., head quarter at Kamakhyaguri town renamed from Kamakhyaguri Construction Subdivision.
- iv) Falakata Subdivision, P.W. Dte., head quarter at Falakata town.
- (b) **Coochbehar Division, P.W.Dte.** under North Bengal Construction Circle-I, P.W.Dte., with head quarter at Coochbehar town shall have four existing Sub-divisions under its administrative jurisdiction, namely
 - i) Coochbehar Sub-division-I, P.W. Dte., head quarter at Coochbehar town.
 - ii) Coochbehar Sub-division-II, P.W. Dte., head quarter at Coochbehar town.
 - iii) Mathabhanga Subdivision, P.W. Dte., head quarter at Mathabhanga town.
 - iv) Dinhata Subdivision, P.W. Dte., head quarter at Dinhata town renamed from Jorai Construction Subdivision.
- (c) **Teesta Bridge Construction Division, P.W.Dte.** under North Bengal Construction Circle-I, P.W.Dte., with head quarter at Mekhligunj town shall have three existing Sub-divisions under its administrative jurisdiction, namely
 - i) Teesta Bridge Construction Sub-division-I, P.W. Dte., head quarter at Mekhligunj town.
 - ii) Teesta Bridge Construction Sub-division-II, P.W. Dte., head quarter at Haldibari town.
 - iii) Teesta Bridge Construction Sub-division-III, P.W. Dte., head quarter at Mekhligunj town.
- (d) **Alipurduar Division, Social Sector, P.W.Dte.** created under North Bengal Construction Circle-I, P.W.Dte., by renaming, shifting and transferring Howrah Division, Social Sector, P.W.Dte. from the administrative jurisdiction of Southern Circle, Social Sector, P.W.Dte., with head quarter at Alipurduar town, to look after the works in social sector within Alipurduar district. The new Division shall have two Sub-divisions under its administrative jurisdiction, namely
 - i) Alipurduar Sub-division, Social sector, P.W. Dte., with its head quarter at Alipurduar town, created by renaming Howrah Sub-division-I, Social Sector, P.W.Dte. and by shifting its head quarter from Howrah town.
 - ii) Falakata Sub-division, Social sector, P.W. Dte., with its head quarter at Falakata town, created by renaming Howrah Sub-

division-II, Social Sector, P.W.Dte. by shifting its head quarter from Howrah town.

- (e) **Coochbehar Division, Social Sector, P.W.Dte.** under North Bengal Construction Circle-I, P.W.Dte., by transferring from the administrative jurisdiction of Northern Circle, Social Sector, P.W.Dte., with head quarter at Coochbehar town, to look after the works of the social sector within Coochbehar district only. The new Division shall have two Sub-divisions under its administrative jurisdiction, namely
 - i) Coochbehar Sub-division-I, Social sector, P.W. Dte., with its existing head quarter at Coochbehar town.
 - ii) Coochbehar Sub-division-II, Social sector, P.W. Dte., as existing Sub-division shifting its head quarter from Coochbehar town to Mathabhanga town.
- (B) **Northern Circle, Social sector, P.W.Dte.**, located at Siliguri shall have three Divisions under its administrative jurisdiction, namely
 - a. North Bengal Division, Social Sector, P.W.Dte.- head quarter at Siliguri town as existing division.
 - b. Malda Division, Social Sector, P.W.Dte.- head quarter at Malda town as existing division.
 - c. Raigunj Division, Social Sector, P.W.Dte.- head quarter at Raigunj town at Uttar Dinajpur. The new Division is created with a office set up of one Executive Engineer (Civil), two numbers of Junior Engineer (Civil) as estimator, one Divisional Accounts Officer, one Head Clerk, two numbers of Upper Division Clerk, two numbers of Lower Division Clerk one Orderly peon and one Peon.
 - (a) **North Bengal Division, Social Sector, P.W.Dte.** under Northern Circle, Social Sector, P.W.Dte., located at head quarter Siliguri town shall have three existing Sub-divisions under its administrative jurisdiction, namely
 - i) Siliguri Sub-division, Social Sector, P.W. Dte.- head quarter at Siliguri town.
 - ii) Jalpaiguri Subdivision, Social Sector, P.W. Dte.- head quarter at Jalpaiguri town.
 - iii) North Bengal Medical College Subdivision, Social Sector, P.W. Dte.- head quarter at Sushrutanagar near Siliguri town renamed from North Bengal University Subdivision, Social Sector.
 - (b) **Malda Division, Social Sector, P.W.Dte.** under Northern Circle, Social Sector, P.W.Dte., with head quarter at Malda town shall have two existing Sub-divisions under its administrative jurisdiction, namely

- Malda Sub-division, Social Sector, P.W. Dte.- head quarter at Malda town.
- ii) Chanchol Subdivision, Social Sector, P.W. Dte.- head quarter at Chanchol town created by renaming Dakshin Dinajpur Subdivision, Social Sector, P.W. Dte. And shifting its head quarter from Balurghat town.
- (c) Raigunj Division, Social Sector, P.W.Dte., newly created under Northern Circle, Social Sector, P.W.Dte., with head quarter at Raigunj town, to look after the works of social sector within Uttar Dinajpur and Dakshin Dinajpur districts. The new Division shall have three Sub-divisions under its administrative jurisdiction, namely
 - i) Raigunj Sub-division, Social sector, P.W. Dte., with its head quarter at Raigunj town, created by renaming Uttar Dinajpur Sub-division, Social Sector, P.W.Dte. and transferring from the administrative control of Malda Division, Social Sector, P.W.Dte.
 - ii) Islampur Sub-division, Social sector, P.W. Dte., with its head quarter at Islampur town, created by renaming Alipurduar Sub-division, Social Sector, P.W.Dte., transferring from the administrative control of Coochbehar Division, Social Sector, P.W.Dte., and shifting from Alipurduar town.
 - iii) Balurghat Sub-division, Social sector, P.W. Dte., with its head quarter at Balurghat town, created by renaming Uluberia Sub-division, Social Sector, P.W.Dte., transferring from the administrative control of Howrah Division, Social Sector, P.W.Dte., and shifting from Uluberia town.
- (C) **Southern Circle, Social sector, P.W.Dte.**, with head quarter at Kolkata shall have five Divisions under its administrative jurisdiction, namely
 - a. Murshidabad Division, Social Sector, P.W.Dte.- head quarter at Baharampur town as existing division.
 - b. Krishnanagar Division, Social Sector, P.W.Dte.- head quarter at Krishnanagar town as existing division.
 - c. North 24 Parganas Division, Social Sector, P.W.Dte.- head quarter at Barasat town as existing division.
 - d. South 24 Parganas Division, Social Sector, P.W.Dte.- head quarter at Kolkata as existing division.
 - e. Kolkata Division, Social Sector, P.W.Dte.- head quarter at Kolkata as existing division
- (D) **Nabanna Circle, P.W.Dte.**, with head quarter at Kolkata shall have three P.W. Divisions under its administrative jurisdiction, namely
 - a. Alipore Division, P.W.Dte.- head quarter at Kolkata as existing division.

- b. Howrah Division, P.W.Dte.- head quarter at Howrah town as existing division.
- c. Howrah Construction Division, P.W.Dte.- head quarter at Howrah town as existing division.
- (a) **Alipore Division, P.W.Dte.** under Nabanna Circle, P.W.Dte., with head quarter at Kolkata shall have five existing Sub-divisions under its administrative jurisdiction, namely
 - i) Behala Sub-division, P.W. Dte., with head quarter at Kolkata.
 - ii) Alipore Subdivision-I, P.W. Dte., with head quarter at Kolkata.
 - iii) Alipore Subdivision-II, P.W. Dte., with head quarter at Kolkata.
 - iv) Alipore Subdivision-III, P.W. Dte., with head quarter at Kolkata.
 - v) Chetla Subdivision, P.W. Dte., with head quarter at Kolkata.
- (b) **Howrah Division, P.W.Dte.** under Nabanna Circle, P.W.Dte., with head quarter at Howrah shall have four existing Sub-divisions under its administrative jurisdiction, namely
 - i) Howrah Sub-division, P.W. Dte., with head quarter at Howrah.
 - ii) Nabanna Sub-division, P.W. Dte., with head quarter at Howrah.
 - iii) Shibpur Subdivision, P.W. Dte., with head quarter at Howrah.
 - iv) Uluberia Subdivision, P.W. Dte., with head quarter at Uluberia town.
- (c) **Howrah Construction Division, P.W.Dte.** under Nabanna Circle, P.W.Dte., located at head quarter Howrah town shall look after all the works of social sector in Howrah district and works already assigned to this Division. The Division shall have three Sub-divisions under its administrative jurisdiction, namely
 - i) Howrah Construction Sub-division-I, P.W. Dte., with head quarter at Howrah as existing.
 - ii) Howrah Construction Sub-division-II, P.W. Dte., with head quarter at Howrah as existing.
 - iii) Uluberia Construction Sub-division, P.W. Dte., with head quarter at Uluberia town, created with a office set up of one Assistant Engineer (Civil) and two Junior Engineer (Civil).

3. Monitoring of Circle cadres under restructured Circles.

For such re-organization and re-jurisdiction of Circles, service of all the existing circle cadre employees under the different circles of PW Dte. shall continue to be maintained in the same circle. However, service of the number of posts in any particular circle cadre who get posted to the other circles due to this re-organization shall be treated

as deemed deputation. This would not adversely effect the seniority or promotion prospect of any circle staff in any manner. The following terms and conditions are to be maintained.

- i) Existing promotional prospects and seniority of the employees in different cadres under existing circles shall remain unaltered till the end of their service in the same circle establishment as before the re-organization.
- ii) The vacancies in the lending establishment shall not be filled up.
- iii) After retirement / promotion or other wise when any post will fall vacant in the lending establishment, the same will stand abolished.
- iv) For creation of any post in the borrowing establishment in the event as stated in (iii) above, concurrence of the Finance Deptt. shall have to be obtained.

4. Accounting implications of the establishments shifted and / or transferred for such re-organization & re-jurisdiction will be in the following manner:

- i) The transfer of Assets and liabilities of account of such re-structuring and rejurisdiction will be maintained in the respective old establishment either renamed or shifted.
- ii) Accounts of the out standing balances under 8443-P.W.Deposit, Suspenses, Closing balances etc. with the erstwhile Divisions will be brought forward in the account of respective same divisions either renamed or shifted.
- iii) Submission of the pending CTIs/CTRs of the erstwhile Divisions will be taken up by the respective same divisions either renamed or shifted.
- 5. This re-organization & re-jurisdiction will take effect from the 1st April, 2017.
- 6. This has the concurrence of the Finance Deptt. vide their UO Nos. Group P2/2016-2017/0510 dated 30.01.2017 and Group P2/2016-2017/0637 dated 08.03.2017.
