**OFFICE ORDER**

In partial modification of the order No 1114/CE(H.Q)/PWD Date. 26.05.2022 following office order is being re issued as follows.:-

A DPR Cell has been formed for necessary assistance to other Government Department regarding preparation of Detailed Project Reports for their various projects.

A through Topographical Survey along with soil investigation report will be primarily required at the very beginning of preparation of DPR.

Now, it may be anticipated that all the proposed sites of various Department will be located at different corners of different districts.


So, considering the present situation and in absence of experienced surveyor and suitable instruments, this is hereby directed to all the Executive Engineers of concerned Divisions of Public Works Directorate, under whose jurisdiction the new projects sites of other Government Departments will be located, to organize detailed topographical survey, soil investigation along with collection of H.F.L. data, through agencies.

They are requested to correlate and keep in touch with the in-charge of DPR Cell and the representatives of other concerned Government Departments, during topographical survey & soil investigation.

The fund for necessary expenditure for Surveying and for preparation of soil investigation report will be provided by the concerned other Government Departments.

An Engineering officer in the rank of Assistant Engineer will authenticate both of the reports & submit the same to the in-charge of DPR Cell.

They are also requested to provide all kinds of assistance during their site visit in different phases of preparation of DPR. A representative in the rank of Assistant Engineer or Junior Engineer will be present at site in different phases of site investigation.






